# The importance of writing a Will and how to do it

### Why should I make a Will?

Making a Will is relatively easy and probably one of the most important things you can do to ensure your wishes are carried out after you have gone. Making a Will can provide you with peace of mind that your family and loved ones will be taken care of in a way that you would like, and causes that matter to you will benefit when you die.

### How do I make a Will?

We strongly recommend using a solicitor or professional Will writer to help you with this as this will ensure that your Will is both valid and accurately reflects your wishes. We cannot recommend a particular solicitor but if you would like us to help you find solicitors in your area who offer a Will writing service, please feel free to contact us.

# How do I update my Will?

Remember, if you already have a Will it is important to review it at least every 5 years to make sure it is up to date, especially if you have experienced any major life-changing events such getting married, having children or purchasing a property. If you would like to update an existing Will, you can choose to either make a completely new Will or add a 'codicil' which sets out any changes to your existing Will and can be read alongside it.

# How do I prepare before visiting my solicitor?

Before meeting with a solicitor, it is helpful to make a list of what you own and owe - this can help you to work out the true value of your estate. You may also like to make a list of all who you would like to benefit from your Will, including family and friends, and any charities or causes that are close to your heart.

You should also consider who will be the executors of your Will - an executor is in charge of carrying out the instructions in your Will. Ideally you would appoint two, and these would be people you can trust, such as family, friends or professional advisors.

# FAQS

#### Q. Do I have to be rich to leave a gift in my Will to Myton?

A. No - however small or large, your gift will help to make a difference and enable Myton to continue its vital work. We receive all kinds of gifts in people's Wills and we are grateful for all support.

### Types of gift you could leave to Myton in your Will:

- **f** Pecuniary Gift this is a cash lump sum (i.e. £5,000).
- Residuary Gift this is made up of the remainder of your estate after cash gifts and other expenses have been paid. You can give the whole residue or a portion of it.
- Specific Gift such as property, land or an individual valuable item such as a piece of jewellery or art.

### Q. Can I leave a gift in my Will to Myton in memory of someone special to me?

A. Absolutely – leaving a gift in your Will is a lasting and wonderful way of remembering your loved one and your gift will forever be recorded as made in their name.

### Q. Can I save on tax by leaving a gift to charity?

A. Yes. By leaving a gift to The Myton Hospices you could reduce your inheritance tax bill because the value of your gift is not taken into account when inheritance tax is calculated.

You could even avoid paying inheritance tax on your estate completely by pledging to give everything over and above the inheritance tax threshold to charity.

#### Q. Do I need to tell Myton that I have left a gift in my Will?

A. Leaving a gift in your Will is a highly personal decision. It is entirely up to you whether or not you inform us of any gift you have made. However, knowing your bequest will help us to plan ahead and say thank you.

#### Q. What details do I need to be able to leave a gift to Myton?

A. If you do decide to leave a gift in your Will to Myton, you will need our details:

#### Q. What wording do I need to use to leave Myton a gift in my Will?

### A. Pecuniary gift

I give free of tax to The Myton Hospices of Myton Lane, Warwick, CV34 6PX, a charity registered in England and Wales (516287), the sum of £\_\_\_\_\_ for the general purposes of The Myton Hospices and I declare that the receipt of its Treasurer or other proper officer shall be a full and sufficient discharge.

### Residuary gift

Subject to the payment of my debts, funeral and testamentary expenses, I give the whole/\_\_\_\_\_ % of my estate not otherwise disposed of by this my Will to The Myton Hospices of Myton Lane, Warwick, CV34 6PX, a charity registered in England and Wales (516287), for the general purposes of The Myton Hospices and I declare that the receipt of its Treasurer or other proper officer shall be a full and sufficient discharge.
